Dear Canton Water Customer

The Canton Public Works Department Water Division in partnership with the MWRA is pleased to provide this report on your drinking water and to communicate our efforts in supplying high quality water to your home.

The Town of Canton has a distribution system of over 128 miles of water mains with more than 6600 service connections, 1100 fire hydrants, five storage tanks, and two pump stations. The system conveys water from the MWRA and local source wells delivering water to homes, businesses, and other facilities for drinking and commercial use. The system is also used for fire protection.

Canton uses an average of 2.5 million gallons of water daily. Twenty percent of this water is supplied by MWRA through a connection to our water system. Eighty percent of the water is supplied from local sources and treated at the James P. Moran and the Edward M. Sullivan Treatment Facilities.

Each day the Canton Public Works Water Division men and women are performing leak detection and repair, checking and verifying pressure, flushing mains and hydrants, and replacing, calibrating, and reading meters. These activities keep Canton's water system safe, decrease the amount of water waste, and increase the Division's financial accountability.

<u>Non-Compliance</u>: During the months of August and October, we had single detections of *E.Coli*, which was a violation of the Total Coliform Rule. This resulted in further testing and adjustments in the chlorine residual. All problems have been resolved. The Canton water system is in full compliance with federal and state health rules and regulations.

<u>Source Water Assessment:</u> MA DEP conducted a Source Water Assessment (SWAP) in 2003 to measure the susceptibility of the Town of Canton's water supply to contamination.
